oncerned friends, community and family members as well as leaders from various spheres gathered in Katutura to march against the brutal killing of the nine-yearold Avihe Cheryl Ujaha on Friday, 07 September 2018. The walk was also dedicated to other victims of sexual and gender-based violence and violence against children.

In her keynote address, Rt. Hon Saara Kuugongelwa-Amadhila urged the public at large to "adopt a stance of no tolerance for crime by reporting any known cases of crime to the relevant authorities and cooperate in every respect with the authorities to ensure that perpetrators are held to account."

It is the firm belief of the Rt. Hon Prime Minister that the time has come for all of us to be proactive and to take a bold stand against crime. "We should ensure that criminals are not allowed any space to carry out their wicked deeds anywhere in this country. We should all become one another's keepers," said Rt. Hon Kuugongelwa-Amadhila.

In conclusion, the Rt. Hon Prime Minister thanked the Namibian Nation for having taken an important step to speak with one voice and to say loud and clear: "no more killing of Namibian women and girls, no more bloodshed and no more raping."

country. "We cannot be having people murdering other people like animals. I think these people have lost value of human life. This is not the Namibia we fought for," fumed the Hon Minister.

Hon. Doreen Sioka, Minister of Gender Equality and Child Welfare, addressing the media on the latest killings of Women and Children and Gender-Based Violence in Namibia.

The press conference started with a moment of silence in honour of the late Avihe Cheryl Ujaha and all other victims who were killed in gender-based violence related cases in Namibia.

Hon. Doreen Sioka condemned the killing of the late Avihe, who was killed at her prime age and a potential leader of this The Hon. Minister alluded to legal instruments which the Government put in place to assist people to live in peace and harmony with one another, such as the Combating of Rape Act, Combating of Domestic Violence Act, Combating Immoral Practices Act, and the recently passed Combating of

Trafficking in Persons Act, 2018 (Act 1 of 2018), amongst others. The Hon Minister cautioned parents and caretakers to really keep an eye on the young ones so that these evil people do not get a chance to lure them out of their sight and make them victims.

She further appealed to the nation to join hands in fighting the scourge of gender-based violence, which is making us lose precious lives. The fight cannot be left only to the Government and Non-Governmental Organizations, such as faith-based organizations.

She urged all and sundry to join hands to cultivate a culture of peace and love for one another. As the Ministry responsible for gender equality and the protection and wellbeing of our children, the Ministry of Gender Equality & Child Welfare strongly condemns the latest gruesome killing of Avihe Cheryl Ujaha and all other victims.

The Hon Minister urged all Namibians to stand up against these senseless killings in pursuit of ZERO Tolerance against gender-based violence.

May the soul of Avihe Cheryl Ujaha and all other victims of gender-based violence rest in eternal peace.

COMMEMORATION OF THE WORLD DAY AGAINST TRAFFICKING IN PERSONS (TIP) 2018

The World Day against Trafficking in Persons was proclaimed by the United Nations General Assembly under its resolution A/RES/68/192. Trafficking in Persons is a serious crime and a grave violation of human rights.

Every year, thousands of men, women and children fall into the hands of traffickers, in their own countries and abroad. Almost every country in the world is affected by trafficking, whether as a country of origin, transit or destination for victims.

Article 3, paragraph (a) of the Protocol to Prevent, Suppress and Punish Trafficking in **Persons** defines Trafficking in Persons as "... the transportation, recruitment. transfer. harboring or receipt of persons, by means of the threat or use of force or other forms of coercion, of abduction, of fraud, of deception, of the abuse of power or of a position of vulnerability or of the giving or receiving of payments or benefits to achieve the consent of a person having control over another person, for the purpose of exploitation."

The Government through the Ministry of Gender Equality and Child Welfare (MGECW) joined the rest of the world to commemorate the World Day Against Trafficking in Persons on Monday, 30 July 2018 in all 14 Regions of Namibia.

The day was commemorated under the theme: "Responding to the trafficking of

children and young people" and the main event was held in Windhoek, Khomas Region. The keynote speaker at the event was Hon. Netumbo Nandi-Ndaitwah, Deputy Prime Minister & Minister of International Relations and Cooperation and the Chairperson of the National High Committee on Trafficking in Persons.

In her keynote address, the Hon. Netumbo Nandi-Ndaitwah stated that "according to the Global Report on Trafficking in Person's 2016, children remain the second largest category of detected victims of trafficking in persons across the world, while women are in the first position.

It is even more shocking that in Sub-Saharan Africa 64% of victims of trafficking are children." It is, therefore, important that adequate attention should be given to the unique needs of children and youth when responding to the scourge of trafficking in persons.

In mitigating the increase of trafficking in Persons, the Government came up with interventions through training of Government officials and relevant stakeholders. In addition, the Combating of Trafficking in Persons Act, 2018 (Act 1 of 2018) has been signed by the President and gazetted.

The Hon. Deputy Prime Minister expressed concern that it is "very sad to learn that people are selling their relatives especially children for whatever

reason better known to them only." She accentuated that it is of paramount importance for Namibia to fight all human trafficking related crimes so as to ensure that our women and children are safe at all times.

The Deputy Minister, Hon Lucia Witbooi concluded the event with a vote of thanks and emphasized to all stakeholders that our mission is to make Namibia free from trafficking in persons.

The event was graced by the presence of Senior Office-Bearers, including Hon. Laura McLeod-Katjirua: Governor of Khomas Region, Florance Situmbeko: International Organization for Migration (IOM), Her Excellency Lisa Johnson: US Ambassador to Namibia, Adv. Martha Imalwa: Prosecutor General, Major-General A.M Nainda: Deputy Inspector General for Administration, and the Deputy Minister of Gender Equality and Child Welfare, Hon. Lucia Witbooi.

In her acceptance remarks the Superintendent, thanked the Management of the Ministry for entrusting her with this vital role. She also thanked her predecessor for the foundation she laid. The Ministry of Gender Equality and Child Welfare decentralized some of its functions, through delegation, to all the Regional Councils on the 9th August 2018, in Oshakati, Oshana Region, with a view to taking Government services closest to the people.

The Ministry is the fifth to decentralize some of its functions, following the Ministry of Education, Arts and Culture, Ministry of Information and Communication Technology, Ministry of Works and Transport, and the Ministry of Land Reform.

The decentralized functions that were delegated to Regional Councils are, to wit, Gender Mainstreaming and Implementation of the National Gender Policy, Income Generating Activities, Integrated Early Childhood Development and Child Welfare Services.

The Ministry of Gender Equality and Child Welfare did not only hand over the delegated functions, but also the necessary resources. Thus financial resources and assets have been transferred to the respective Regional

Councils. Staff members based at all the Regional Offices of the Ministry of Gender Equality & Child Welfare have been seconded to the Regional Councils and they, therefore, report directly to the Regional Councils. The devolution phase of decentralization will follow once the time is ripe.

The decision to decentralize these functions was triggered by the need to accelerate service delivery at grassroots level. Moreover, decentralization will

enhance socio-economic and cultural development as it will afford people at grassroots level the opportunity to take part in their own decision-making and thus extend democracy up to local level.

PARTNERING TO ADVANCE WOMEN ENTREPRENEURS IN NAMIBIA

n the 06th September 2018 the Ministry of Gender Equality and Child Welfare, in conjunction with De Beers Group and UN Women partnered to advance Women entrepreneurs. The aim of the partnership is to support 500 women-owned micro-enterprises in Namibia through a dedicated training program to help formalize and grow their businesses.

The program will focus on providing women entrepreneurs with knowledge and skills in the areas of marketing, recordkeeping, stock management, costing and business planning, with the ultimate objective of supporting them to increase their revenue, create new jobs, sustain existing jobs, and improve the predictability and sustainability of their income.

The Hon Doreen Sioka, Minister of Gender Equality and Child Welfare, welcomed the partnership and emphasized that the Ministry of Gender Equality and Child Welfare is committed to supporting entrepreneurs in line with the objectives of our NDP 5.

According to Mr Daniel Kali, Resident Director: De Beers Group, De Beers Group has made a commitment to support women and girls around the world, especially in our diamond-producing countries where women play a vital role in supporting their local communities.

CAPACITY-BUILDING WORKSHOP FOR THE YOUTH

The workshop was attended by Social Workers, Administrative Officers and Volunteers from Kavango East, Kavango West, Zambezi and Ohangwena staff members Regions, (facilitators) from **MGECW** Head Office and Senior Health Programme Officers from the Ministry of Health & Social Services.

REGIONAL TRAINING ON CASE MANAGEMENT

The Ministry of Gender Equality and Child Welfare through Child Welfare Directorate is in the process to introduce Case Management System in all regions.

The Case Management system started last year in Kavango West and East Regions where it was piloted. After successful piloting in the abovementioned Regions, the Ministry decided to roll out the process to all Regions.

So far six (6) regions were trained on the Case Management processes. These regions are Oshana, Otjozondjupa, Khomas, Kunene, //Kharas and Hardap. The roll out of the trainings will continue to the rest of the regions.

DAY OF THE NAMIBIAN CHILD

t was on 28th September 1990 that Namibia as a country ratified the United Nations Convention on the Rights of the Child, and consequently the 28th September was declared a national day by Cabinet in the year 2000. Since then, the day has been celebrated yearly with different themes aimed at raising awareness on the plight of children.
