# SADC MINISTERS OF GENDER AND WOMEN'S AFFAIRS MEETING

The SADC Meeting of Ministers responsible for Gender/Women's Affairs was held on 29 May 2019 in Windhoek, Namibia. The meeting was attended by representatives from Angola, Botswana, Democratic Republic of Congo, Lesotho, Malawi, Mauritius, Mozambique, Namibia, South Africa, Tanzania, Zambia and Zimbabwe.

The decisions taken by the Meeting are, inter alia, as follows:

Ministers urged Member States who have not yet signed the Agreement Amending the SADC Protocol on Gender and Development to expedite the process of signing the Agreement and report to Council in 2019.

Ministers approved the Draft Report of the Analytical Assessment of Gender Mainstreaming in the SADC Region, and its recommendations, while noting that the Secretariat will finalise the Secretariat section in the report and circulate the improved circulation to Member States by 30th June 2019. Ministers directed the Secretariat to revise the Gender Mainstreaming Resource Kit, and submit to the next Ministerial Committee's Meeting.

Draft Ministers approved the Multi-Dimensional Regional Women's Economic Empowerment Programme. Ministers recommended to Council Ministers that SADC rallies behind the Republic of Zimbabwe in calling for the removal of the sanctions imposed on the country, which among others negatively affects women, the elderly, disabled and children, and to:

- i. Express continued solidarity with the Republic of Zimbabwe;
- ii. Agree on a particular date on which women and all SADC Member States can voice their disapproval, and a united on-going call for the removal of sanctions on Zimbabwe; and
- iii. Devise collective mechanisms to support the Republic of Zimbabwe in the removal of sanctions, and support the Republic of Zimbabwe on her path towards socio-economic transformation.

Ministers endorsed the Draft GBV Comprehensive Report and its recommendations for further consideration by the Joint Meeting of Ministers responsible for Gender, and the Ministerial Committee of the Organ (MCO), and directed the Secretariat to include information on the linkage between GBV and escalation of HIV and AIDS.

Ministers directed the SADC Secretariat to finalise the report by including information on the linkage between GBV and escalation of HIV and AIDS and circulate to Member States by 15th June 2019, and urged Member States to submit comments by 30th June 2019.

Ministers directed the Secretariat to mobilise resources for developing a tool to measure the multi-dimensional impact of GBV on the SADC Member States economies with specific focus on GDP.

Ministers directed the Secretariat to submit a report on the development and roll-out of the tools to guide the regional response on gender-based violence to their next meeting in 2020.

Ministers urged the remaining Member states who are yet to develop National Action Plans to do so, and continue to mobilise resources to implement the national strategies.

I on Doreen Sioka, Minister of Gender Equality and Child Welfare, was the guest of honour

and keynote speaker Otiinene Expo 2019, on 3 May 2019 at Otjinene, Omaheke Region.

The Hon Minister emphasized the importance of agriculture, trade and industrialization in the

improvement of the quality of life of the Namibian citizenry, particularly the rural communities.

The Hon Minister reminded the show-goers that the agricultural sector 'sustains about 70% of the Namibian population' and is thus a significant backbone of the Namibian economy.

Hon Sioka utilized the same platform and addressed a number of pertinent issues relating to gender equality, child welfare and women economic development.

The Minister urged the community to extend the application of the concept of 50/50 representation to the leadership of the Village Council, Expo Committee, Constituency Development Committees, School Boards. Farmers Associations. Water Point Committees, and all societal decision-making structures. Hon Sioka further drew the attention of the audience to the legal instruments that have been recently operationalized by the MGECW in respect of trafficking in persons, and child care and protection.

The Hon Minister urged the public at large to stop giving money to children on the street. In her words, 'giving money to children on the street worsens the problem, and is

> thus not a solution in any way.'

> The abuse of child welfare grants by the recipients to the extent that the intended beneficiaries (i.e. orphans and vulnerable children)

do not really receive the intended benefits, is a major concern to the Hon Minister.

Hon Sioka called upon every community member to report any abuse of child welfare grants or fraudulent receipt of grants to the offices of the Ministry of Gender Equality and Child Welfare their respective Regions and Constituencies.

In conclusion, Hon Doreen Sioka officially opened the Otjinene Expo 2019 and wished everyone fruitful business engagements ahead.

# **HYDROPONICS** AND GARDENING



he After School Centre (ASC) with the technical support of UN World Food Programme has revamped the ASC garden by introducing Hydroponics and Polyponics. This is a system that uses less water and the crops grow fast.

The ASC is using unemployed parents of the children accessing the facility and would be training more parents to start water-saving gardening methods at their homes or backyards.

The ASC hopes to introduce the project in Gobabis for the parents and guardians of the children living and working on the street to be able to generate an income and alleviate poverty.

# ZIMBABWE-NAMIBIA JOINT TRADE

Zimbabwe-Namibia Joint Trade Committee Meeting and Visits on Exports of Fresh Fruits and Vegetables 27-31 May 2019, have been organized by the Zimbabwe-Namibia Joint Trade Committee. The meeting deliberated on the following areas of cooperation: Trade, Finance, Agriculture and SMEs, Tourism, Environment, Transport, Mines, Energy, Gender and Health.

The Ministry will continue with the implementation of the of MoU on Cooperation in Women Empowerment, Gender equality and Community Development, and the Directorate of Community Empowerment will be responsible to organize an exchange programme under WBA for women agriculture related IGAs to visit their peers in Zimbabwe.

The main discussions of the meeting centered on the areas of cooperation with particular emphasis on the export of fresh fruits and vegetables from Zimbabwe to Namibia and the export requirements which necessitated the visit by technical experts from Namibia.

The Namibian technical experts shared export requirements applicable to both companies and individuals who wish to access the Namibian market. The delegation also underscored the Market Share Promotion Scheme (MAPS) which requires fresh produce suppliers in Namibia to source at least 40% of the required fresh produce locally under the auspices of the Ago – Marketing Trade Agency prior to importing the variance.

The Zimbabwe private sector companies presented opportunities and capacities of Zimbabwe to export an assortment of agro-

produce to Namibia

The Namibia delegation accompanied by the Zimbabwean counterparts undertook field visits to companies and individuals who expressed interest to export, including the companies which made presentations.

The delegation visited Zimbabwean horticulture producers and pack houses in Marondera and Chipinge, quarantine facilities in Harare and Mazowe, and the port of exit at R.G. Mugabe International Airport.

The outcomes of the visit confirmed that the phyosanitary measures are in place to prevent the introduction and spread of pest and diseases. Monitoring and surveillance of different pest are being conducted by farmers and plant quarantine officials of the government of Zimbabwe.



# **CASE MANAGEMENT TRAINING**

MGECW Social Workers and Administrative Officers in Ohangwena Region were trained on case management from 6 - 10 May 2019. The workshop was financially supported by Project Hope Namibia through USAID.

Staff members of the Ministry at national level provided technical support in terms of training. The staff members from the above-mentioned Region were trained on Operational Case Management Manual that provides guidance on all aspects of social work case management practice for both cadres. A total number of 28 regional staff members were trained.

The objectives of the workshop were, inter alia:

- To enhance the understanding of the strengthened case management system across the MGECW;
- To explore social work practice and case management principles from children's rights based perspective;
- To promote coordinated case management approaches between the administrative officers and social workers as well as stakeholders;
- To enable social work supervisors / senior social workers to provide supportive supervision and transfer case management knowledge, skills and tools to MGECW social workers.
- To prepare MGECW to engage stakeholders with the case management system and explore opportunities for strong collaboration.

On the last day of the training, a plan for the regions on how case management will be rolled out was developed and different staff at different levels were assigned responsibilities towards the implementation of the Case Management system in the region. A follow-up visit is expected to take place three months after the training to look at the implementation of the Case Management System.

# SYMPOSIUM FOR CHILDREN WITH DISABILITIES IN NAMIBIA

The Symposium for Children with Disabilities in Namibia was held on 21 May 2019. The Justus-Liebig Universtat Giessen in collaboration with Namibia University of Science and Technology hosted a Get-Together Symposium on Children with Disabilities at the NUST Hotel School.

The Symposium focused on the following items:

Situational analysis and special needs of children living with disabilities in Namibia.

Special education in early childhood as a topic for academic research activities and curricula.

Collaboration and cooperation in research, training and partnership support for projects.

Various stakeholders and including the Ministry of Gender Equality and Child Welfare (through Child Welfare Services Directorate) attended the symposium; and representatives of various facilities working with children living with disabilities such as Die Lebenschule, Walvisbay Child and Family Centre, Dagbreek School for Children with Special Needs, Clach, Hand in Hand, and many more.

#### HIV AND GENDER-BASED VIOLENCE THROUGH INTEGRATED CASE MANAGEMENT

With support from CDC / UNICEF, social workers from MGECW have teamed up with the Ministry of Health and Social Services to strengthen the Government's collective response efforts around HIV and gender-based violence.

A lot of great work was demonstrating the value of integrative case management approaches.

Social workers proved to be highly instrumental around navigating systems and issues around new HIV diagnosis, disclosure, adherence and ridding the barriers to care. The MGECW sincerely recognises



and thanks all the social workers who continue to be a part of these ongoing efforts. The MGECW also thanks the six response social workers who were hired for three months to offer supplementary support in selected regions. There still is so much more to do around creating a solid integrative case management system for Namibia. However, slowly but surely, we are getting there.

# REFRESHER TRAINING OF TRAINERS WORKSHOPS

The Refresher Training of Trainers (TOT) workshops for Administrative Officers on Adolescents, Girls and Young Women (AGYW) Criteria were conducted as follows:

Training held 6 to 10 May 2019; 13 to 17 May 2019 and 17 to 21 June 2019 took place in Otjiwarongo, while the training that took place from 17 to 21 was held in Tsumeb.

 17 to 21 June 2019 in Otjiwarongo at C'est Si Bon: A total number of 109 Administrative- and Senior Administrative Officers were trained.

The main issues discussed in the workshop are:

- Tools to assess vulnerability by using the following forms: Risk Assessment, CR1, CM 1-Reporting Form and CM Referral Form.
- Discussions on various grant types according to the CCPA (state maintenance grant, foster parent grant, kinship care grants, residential child care grant, child disability grant and short term emergency grant).
- How to identify vulnerable children including AGYW in the community for other services.



- Understanding on collaboration between MGECW Administrative Officers (AOs) and Community Health Workers (CHW).
- Reviewed criteria on eligibility of children on the Social Assistance System (SAS).

Staff members are expected to go back to their respective regions/ constituencies and conduct training on vulnerability criteria for AGYW to the CHW who will in return identify and refer such group of people to the MGECW and other appropriate service providers.

#### TRAINING ON SEXUAL VIOLENCE RESPONSE

The training on sexual violence victims for Social Workers and Police Officers was initiated by the Ministry of Gender Equality and Child Welfare under the Global Fund financial support. It was convened from 24 - 28 June 2019. The aim of the training is to strengthened collaboration

between the two officials dealing with victims at Gender-Based Violence Protection Units or at any police station, for effective and efficient service delivery to victims of Gender-Based Violence and Violence Against Children.

Specific objectives of the training are:

- To understand factors involved while dealing sexual violence victims;
- To strengthen continuum response to victims; and
- To clarify the role and responsibilities of the Social Workers and police officers while dealing with victims.

The launch was done at the After School Centre by the Director of General Services Mr Nichlas Mbingeneeko on behalf of Hon Doreen Sioka.

The event took place on 12 April 2019 at the After School Centre. The theme of the event was "Children Living and working on the street: Leave no child behind for Namibia's development" and the slogan



behind the theme was that "Giving Money to Street Children is part of the problem and not the solution".

#### The outreach

The street outreach and awareness with posters and flyers on children on the streets was conducted on the 13 April 2019, prior the commemoration of International Day for children on the streets.



The activity was conducted at different street corners and traffic lights that are hotspots where street children use to beg (zula), namely Klein Windhoek Hidas Centre, Traffic lights of WHK High School and Traffic lights of Roads Authority and

Game. Staff members of ASC, Head Office and Jacob Marengo School (Children's Movement) handed out flyers and raised awareness on the services available for street children.
