Based on the sample presented by the suppliers, the Bid Evaluation Committee has recommended 1 (one) lowest evaluated substantially responsive bidder, for books and posters to Nghanidiza Investments cc for the amount of N\$ 176 870.00. The bidder has provided quality and strong materials needed for books and poster. Anspri's Trading cc failed to submit their sample for books. Thus they were disqualified.
