



D. RECOMMENDATION BY PROCUREMENT COMMITTEE

The Procurement Committee considered bids that are within the budgeted amount of N\$ 8 160 000,00 and N\$ 6 936 000,00 (15% of the affordability line below the Budgeted amount) be regarded as substantially responsive. The Procurement Committee further recommended to award per lots, thus **Punchu Trading cc** is recommended to supply **Lot A (Food items)** to the amount of N\$ 6 800 989,96, while **T & S Global Trading cc** is for **Lot B (Non-food items)** to the amount of N\$ 624 222,39 for a period of Thirty Six (36) Months.
